WHEREAS WAAT has helped its members to become productive contributing members to the profession and their communities;

## **Holiday Party**

WAAT celebrated its annual holiday party at the Kansas Museum of History on December 12. In honor of WAAT's 35<sup>th</sup> Anniversary in 2020, President Amber Smith read a resolution passed by the Board of Directors to commemorate the occasion. The resolution was also passed at the December Board of Directors meeting and shared on the WAAT listserv.

The museum is currently commemorating the 100<sup>th</sup> anniversary of the 19<sup>th</sup> Amendment's passage with a special exhibit, *#MarthaMakesHistory*. The exhibit follows a year in the life of "everyday revolutionary" Martha Farnsworth, a Topeka suffragist who kept a diary of her life on an almost daily basis for nearly 40 years. She worked hard for the cause of suffrage but lived a life typical of women of her day. The exhibit will be open to the public through December 2020.

In addition to a private viewing of the exhibit and a presentation from the curator of the exhibit, Senior Archivist Megan Rohleder, the traveling exhibit "*100 Years After the 19th Amendment: Their Legacy, and Our Future*" from the American Bar Association's Standing Committee on the Law Library of Congress 19th Amendment Centennial was displayed.
